[CPSC Report on Pediatric Poisoning](#)

The CPSC released its "Annual Report on Pediatric Poisoning Fatalities and Injuries," finding a nearly 10% increase in emergency department-treated injuries in children under 5 between 2021 and 2022. In particular, the CPSC noted an increase in unintentional pediatric poisonings involving acetaminophen, ibuprofen, and narcotics. They also call attention to new evidence suggesting that toxicity in water bead products may lead to adverse health effects in children. For more information, contact

CPSC Product Warnings

This month, the Consumer Product Safety Commission (CPSC) has issued product warnings for eight products sold on Amazon.

The CPSC is warning consumers to immediately remove the battery packs from the [EVERCROSS EV5 hoverboards](#) and dispose of them following local hazardous waste disposal procedures because they pose a risk of fire to consumers.

Two water bead products, the "[Tuladuo Water Bead Sets](#)" and the "[Jangostor Large Water Beads](#)," contain levels of acrylamide in violation of the Federal Hazardous Substances Act, posing a risk of toxicity to children. Additionally, when ingested, water beads can cause severe discomfort, vomiting, dehydration, intestinal blockages or life-threatening injuries that can require surgery to remove them.

The "[XHJRI Braided Crib Bumpers](#)" are banned by the federal Safe Sleep for Babies Act, posing a suffocation hazard to infants. Likewise, the "[Comfi Baby Infant Walkers](#)" violate the federal safety regulations for infant walkers, posing a risk of falls and entrapment to children.

Following the recall of three similar roller ball [candy products](#) and the death of a 7-year-old girl, the CPSC is warning consumers about the choking risk associated with these products. The candy's rolling ball can dislodge and become trapped in a child's throat, posing a fatal choking risk.

The CPSC also warns consumers to stop using the "[Elide Fire Extinguishing Balls](#)" and "[Faddare 16.4 Foot Extension Power Cords](#)."

[March 28, 2024 CPSC](#); Forias Pack and Play Mattresses sold on Amazon have been recalled because they violate multiple provisions of the Safety Standard for Crib Mattresses, including the thickness test and missing the required warnings and labels, posing a suffocation hazard to infants. Holiday Starbucks-branded Gift Sets because if microwaved or filled with extremely hot liquid, the mugs can overheat or break, posing burn and laceration hazards. Units: About 440,500.

[March 21, 2024 CPSC](#); Fisher-Price recalled its Little People Mickey and Friends Figures because the heads of the Donald Duck and Daisy Duck figures can detach, posing a choking hazard to young children. Units: About 204,000 (an additional ~11,000 in Canada).

[March 14, 2024 CPSC](#); Twenty Four Six Foods recalled its Happiness USA Liquid Rolling Candy because the ball can dislodge from the product into a child's mouth, posing a choking hazard and risk of death. Units: 290,000.

[March 14, 2024 CPSC](#); Best Buy recalled its Insignia® Air Fryers and Air Fryer Ovens because they can overheat, causing the handles to melt or break and/or the glass on the door to shatter, posing fire, burn, and laceration hazards. Units: About 187,400 (an additional ~99,900 in Canada).

[March 7, 2024 CPSC](#); Honeywell recalled its System Sensor L-series low frequency Sounders and Strobes for residential apartments and commercial buildings because the sounders and strobes can malfunction and cause the fire alarm system to fail to alert consumers of a fire. Units: About 29,000.

[March 7, 2024 CPSC](#); Getallfun recalled its 216-Piece 5mm Magnet Balls because they because the toy sets do not comply with the requirements of the mandatory federal toy regulation and pose a risk of serious injury or death if ingested by children. When two or more small, powerful magnets are swallowed, surgery is often needed to remove them and fix the damage. Units: About 1,140.

[March 7, 2024 CPSC](#); Jool Baby recalled its Nova Baby Infant Swings because they were marketed, intended, or designed for infant sleep, and they have an incline angle greater than 10 degrees in violation of the CPSC's Infant Sleep Products Regulation and the Safe Sleep for Babies Act, posing a suffocation risk. Units: About 63,100.

[March 7, 2024 CPSC](#); TJX recalled its Tommy Bahama brand children's pants sets because the plastic pieces on the end of the pants' faux drawstrings can come loose and fall off, posing a choking hazard. Units: About 14,500 (an additional ~660 in Canada).

[March 7, 2024 CPSC](#); SINGES 3-in-1 Baby High Chairs and Booster Seats sold on Walmart have been recalled because the recalled high chair, which converts into a booster seat, violates the safety regulations for both high chairs and booster seats, posing a fall hazard to children. Units: About 175.

[March 7, 2024 CPSC](#); Bubble Bear Crib Mattresses sold on Amazon have been recalled because they violate the federal safety regulation for mattresses by failing to meet the flammability and labeling requirements, posing a fire hazard to children. Units: About 750.

[March 28, 2024 CPSC](#); BJ's Wholesale Club recalled its Citronella 72-inch Tiki Torches because the tiki torch top can break open and/or fall off while lit, posing a burn hazard. Units: About 90,000.

[March 28, 2024 CPSC](#); Forias Pack and Play Mattresses sold on Amazon have been recalled because they violate multiple provisions of the Safety Standard for Crib Mattresses, including the thickness test and missing the required warnings and labels, posing a suffocation hazard to infants. Units: About 1,900.

[March 28, 2024 CPSC](#); Stateside Bead Supply recalled its Magnetic Beads HIGH POWER 5mm because they do not comply with the requirements of the mandatory federal toy regulation and pose a risk of serious injury or death if ingested by children. When two or more small, powerful magnets are swallowed, surgery is often needed to remove them and fix the damage. Units: About 450.

[March 21, 2024 CPSC](#); BRS and BULin Liquid Fuel Bottles sold on Amazon have been recalled because they violate the child-resistant requirements for closures under the Children's Gasoline Burn Prevention Act (CGBPA), posing a risk of burns and poisoning to children. Units: About 290.

[March 21, 2024 CPSC](#); Nestle USA recalled its Metallic Mugs included in 2023 Holiday Starbucks-branded Gift Sets because if microwaved or filled with extremely hot liquid, the mugs can overheat or break, posing burn and laceration hazards. Units: About 440,500.

[March 21, 2024 CPSC](#); Crown Boiler recalled its Crown Aruba IV (AWR Series) gas-fired hot water boilers because, under specific circumstances, the blocked vent switch can fail to shut down, causing excess amounts of carbon monoxide and posing a poisoning hazard to consumers. Units: About 1,100.

[March 21, 2024 CPSC](#); Fisher-Price recalled its Little People Mickey and Friends Figures because the heads of the Donald Duck and Daisy Duck figures can detach, posing a choking hazard to young children. Units: About 204,000 (an additional ~11,000 in Canada).

[March 21, 2024 CPSC](#); Culture Kings recalled its Sneaker Basel Magnetic Levitation Displays because it's the sneaker display's magnets can forcefully attract, break, splinter and emit sparks, posing a laceration hazard. Additionally, when two or more small, powerful magnets are swallowed, surgery is often needed to remove them and fix the damage. Units: About 4,300.

[March 14, 2024 CPSC](#); Twenty Four Six Foods recalled its Happiness USA Liquid Rolling Candy because the ball can dislodge from the product into a child's mouth, posing a choking hazard and risk of death. Units: 290,000.

[March 14, 2024 CPSC](#); U.S. Boiler Company recalled its U.S. Boiler, New Yorker

Boiler, Advantage, FORCE and Archer brand gas-fired hot water residential boilers because, under specific circumstances, the blocked vent switch can fail to shut down, causing excess amounts of carbon monoxide and posing a poisoning hazard to consumers. Units: About 2,500.

[March 14, 2024 CPSC](#); Best Buy recalled its Insignia® Air Fryers and Air Fryer Ovens because they can overheat, causing the handles to melt or break and/or the glass on the door to shatter, posing fire, burn, and laceration hazards. Units: About 187,400 (an additional ~99,900 in Canada).

[March 7, 2024 CPSC](#); Fossil Group recalled its Bracelet sold with Skechers Watch and Jewelry Gift Sets because the clasp on the braided black bracelet sold as part of the gift set contains high levels of lead and cadmium, posing a risk of adverse health effects in children.

[March 7, 2024 CPSC](#); Anker Innovations recalled its EverFrost Battery Powered Coolers because the lithium-ion batteries in the Anker EverFrost Coolers can overheat, posing a fire hazard. Units: About 5,480 (in additional ~160 in Canada).

[March 7, 2024 CPSC](#); Getallfun recalled its 216-Piece 5mm Magnet Balls because they because the toy sets do not comply with the requirements of the mandatory federal toy regulation and pose a risk of serious injury or death if ingested by children. When two or more small, powerful magnets are swallowed, surgery is often needed to remove them and fix the damage. Units: About 1,140.

[March 7, 2024 CPSC](#); Stones Toy Creativity Development DIY Magnetic Beads sold on Walmart have been recalled because the toy sets do not comply with the requirements of the mandatory federal toy regulation and pose a risk of serious injury or death if ingested by children. When two or more small, powerful magnets are swallowed, surgery is often needed to remove them and fix the damage. Units: About 650.

[March 7, 2024 CPSC](#); GT recalled its LaBomba bicycles because the bicycle headtube/downtube weld can become damaged and separate from the bicycle frame, posing fall and injury hazards. Units: About 3,040 (an additional ~324 in Canada).

[March 7, 2024 CPSC](#); Yamaha Corporation of America recalled its Yamaha PA-10 AC Power Adaptors because a crack can occur between the PA-10 AC Power Adapter's upper and lower cases. This can cause the cases to separate and expose electrical wiring, posing electrical shock and electrocution hazards to consumers. Units: About

34,500.

[March 7, 2024 CPSC](#); Sleep Technologies recalled its Eco Terra Hybrid Latex Mattresses because they violate the smoldering ignition requirements of the federal mattress flammability regulation, posing a fire hazard. Units: About 84.

[March 7, 2024 CPSC](#); TJX recalled its Tommy Bahama brand children's pants sets because the plastic pieces on the end of the pants' faux drawstrings can come loose and fall off, posing a choking hazard. Units: About 14,500 (an additional ~660 in Canada).

[March 7, 2024 CPSC](#); SINGES 3-in-1 Baby High Chairs and Booster Seats sold on Walmart have been recalled because the recalled high chair, which converts into a booster seat, violates the safety regulations for both high chairs and booster seats, posing a fall hazard to children. Units: About 175.

[March 7, 2024 CPSC](#); Bubble Bear Crib Mattresses sold on Amazon have been recalled because they violate the federal safety regulation for mattresses by failing to meet the flammability and labeling requirements, posing a fire hazard to children. Units: About 750.
