ANNOUNCEMENTS

CPSC Product Warnings

This month, the CPSC has issued a series of product warnings that include small powerful magnets, crib mattresses, and lithium-ion replacement battery packs.

The "Pedetid 216-Piece 5mm Magic Magnet Ball Sets," sold exclusively on Walmart.com, do not comply with the requirements of the mandatory federal toy regulation and pose a risk of serious injury or death if ingested by children. When two or more small, powerful magnets are swallowed, surgery is often needed to remove them and fix the damage.

The CPSC also warns consumers to immediately stop using "<u>Hygge Hush Flat Classic Logo Style play yard mattresses</u>" because they violate the federal safety regulations for crib mattresses, posing a suffocation hazard to infants.

The "ZAUTNKN.INC lithium-ion replacement battery packs" for Dyson Vacuums sold Amazon.com have not had their performance and safety verified to meet national safety standards. There have bee three reports of fires associated with the battery packs.

<u>January 25, 2024 CPSC</u>; Yaomiao Children's Rhinestone Silver Tiaras, sold exclusively on Amazon, have been recalled because the rhinestones contain levels of lead that exceed the federal lead content ban, posing a risk of adverse health effects to young children if ingested. Units: About 12,440.

<u>January 24, 2024 CPSC</u>; Haleon recalled eight lots of its Robitussin Honey CF Max Day Adult and Nighttime Adult cough syrups due to microbial contamination, posing a risk of severe of life-threatening adverse events or infection to immunocompromised consumers.

<u>January 18, 2024 CPSC</u>; Bokser Home recalled its 100% Cotton Mattress Pads because they violate mandatory federal flammability regulation for mattress pads, posing a fire hazard. Units: 2,300.

<u>January 18, 2024 CPSC</u>; Home Design recalled its Upholstered Low Profile Standard and Platform Beds because the recalled beds can break, sag, or collapse during use, posing fall and injury hazards to consumers. Units: About 527,177 (an additional ~55,847).

January 11, 2024 CPSC; Alliance4Safety and 31 Furniture Companies recalled its New Age Industries Furniture tip kits or tip restraints because the plastic zip tie used with the recalled furniture tip kits can become brittle or break, which can allow a clothing storage unit that is anchored to the wall to detach during a furniture tip-over event, posing a tip-over and entrapment hazard that can result in death or serious injuries to children. Units: Millions.

January 11, 2024 CPSC; Retrospec recalled its Scout Kid's Bike Helmets because

they do not comply with the coverage, positional stability, and labeling requirements of the CPSC federal safety regulation for bicycle helmets. The helmets can fail to protect in the event of a crash, posing a risk of head injury. Units: About 72,000 (an additional ~150 in Canada)

<u>January 4, 2024 CPSC</u>; Homedics recalled its Therapist Select Percussion Personal Massagers because they can overheat while charging, posing fire and burn hazards. Units: About 46,000 (an additional ~41,000 in Canada).

RECALLS

<u>January 25, 2024 CPSC</u>; Visual Comfort & Co. recalled its Maverick Coastal 60-inch Outdoor Ceiling Fans because the fan's blade can crack or break and fall off the unit, posing an impact injury hazard. Units: About 6,400 (an additional ~200 in Canada).

<u>January 25, 2024 CPSC</u>; Yaomiao Children's Rhinestone Silver Tiaras, sold exclusively on Amazon, have been recalled because the rhinestones contain levels of lead that exceed the federal lead content ban, posing a risk of adverse health effects to young children if ingested. Units: About 12,440.

<u>January 25, 2024 CPSC</u>; Pacific Cycle recalled its Ascend Cabrillo and Minaret Electric Bikes because the wiring harness that manages the charging of the lithiumion battery was not properly assembled, creating a risk of overheating and fire while charging. Units: About 1,700.

<u>January 25, 2024 CPSC</u>; Clark Associates recalled its Allegro plastic side chairs because they can break apart while in use, posing a falling hazard. Units: About 53,800.

<u>January 25, 2024 CPSC</u>; BRS Fuel Bottles, sold exclusively on Amazon, have been recalled because the portable fuel bottles do not meet the child-resistant requirements for closures under the Children's Gasoline Burn Prevention Act (CGBPA). The closure for the products is not child resistant, posing a risk of burn and poisoning to children. Units: About 165.

<u>January 24, 2024 CPSC</u>; Haleon recalled eight lots of its Robitussin Honey CF Max Day Adult and Nighttime Adult cough syrups due to microbial contamination, posing a risk of severe of life-threatening adverse events or infection to immunocompromised consumers.

<u>January 18, 2024 CPSC</u>; Bokser Home recalled its 100% Cotton Mattress Pads because they violate mandatory federal flammability regulation for mattress pads, posing a fire hazard. Units: 2,300.

<u>January 18, 2024 CPSC</u>; Steamist recalled its Wall-Mounted Tilt-Up Bath & Shower Seats because the bracket and seat rods supporting the Tilt-Up Bath & Shower Seat can corrode and break, posing fall and laceration hazards. Units: About 3,900 (an

additional ~733 in Canada and ~126 in Mexico).

<u>January 18, 2024 CPSC</u>; Home Design recalled its Upholstered Low Profile Standard and Platform Beds because the recalled beds can break, sag, or collapse during use, posing fall and injury hazards to consumers. Units: About 527,177 (an additional ~55,847).

January 11, 2024 CPSC; Alliance4Safety and 31 Furniture Companies recalled its New Age Industries Furniture tip kits or tip restraints because the plastic zip tie used with the recalled furniture tip kits can become brittle or break, which can allow a clothing storage unit that is anchored to the wall to detach during a furniture tip-over event, posing a tip-over and entrapment hazard that can result in death or serious injuries to children. Units: Millions.

<u>January 11, 2024 CPSC</u>; Retrospec recalled its Scout Kid's Bike Helmets because they do not comply with the coverage, positional stability, and labeling requirements of the CPSC federal safety regulation for bicycle helmets. The helmets can fail to protect in the event of a crash, posing a risk of head injury. Units: About 72,000 (an additional ~150 in Canada)

<u>January 4, 2024 CPSC</u>; Bell Sports recalled its Bell Slope Adult Bicycle Helmets because the strap anchor can become dislodged from the helmet when sufficient force is applied, and therefore violates the CPSC federal safety regulation for bicycle helmets. The helmets can fail to protect in the event of a crash, posing a risk of head injury. Units: About 11,000.

<u>January 4, 2024 CPSC</u>; UBBCARE Play Yard Mattresses, sold exclusively on Amazon, have been recalled because they violate multiple provisions of the federal safety regulation for crib mattresses, including the thickness test, and are missing warnings and labels. The product poses a suffocation hazard to infants. Units: About 1,000.

<u>January 4, 2024 CPSC</u>; Ride Aventon recalled its Class 2 Sinch.2 Folding E-Bicycles because they can accelerate unexpectedly, resulting in loss of control, posing crash and injury hazards. Units: About 2,300.

<u>January 4, 2024 CPSC</u>; Homedics recalled its Therapist Select Percussion Personal Massagers because they can overheat while charging, posing fire and burn hazards. Units: About 46,000 (an additional ~41,000 in Canada).

- Be careful about using hand-me-downs or buying children's products at a secondhand shop or yard sale.
